# **About the Fund**

The Acruence Active Hedge U.S. Equity ETF (XVOL) The Acruence Active Hedge U.S. Equity ETF (XVOL) is an actively-managed exchange-traded fund (ETF) that seeks capital appreciation with less volatility than the S&P 500 Index.

Acruence seeks to achieve its objective by investing nearly all of the ETF's assets in a broad-based U.S. large-cap equity portfolio, composed of approximately 50% momentum growth stocks and 50% dividend yield stocks. The fund seeks to enhance income by call and put writing, selectively, while seeking to reduce volatility by purchasing options contracts on the VIX (i.e., the Cboe Volatility Index).

Acruence uses proprietary, volatility-based algorithms to determine the number of options contracts to purchase, as well as the strike price(s) and expiration date(s) of the options.
